THIS AGREEMENT ("Agreement") is by and between Kamp Kanine (hereinafter referred to as "KK") and the Owner of the Dog, (hereinafter referred to as "Client"). Intending to be legally bound, the parties agree as follows:

I, \_\_\_\_\_ Client (Owner of Dog), accept responsibility for any damages the above named dog(s) may cause through malicious, aggressive or improper behavior that may occur before, during or transportation to or from daycare or off-site activity location. Furthermore, I understand and agree that if my dog is injured in a dog fight or an accident, gets fleas, ticks or worms, contracts any illness or disease, is lost or stolen, becomes pregnant, or engages in any dangerous, vicious or unwanted behavior, during or after the term of this Agreement, on or off KK Premises, off-site activity location Clients Home or Business or during transportation, that I accept the risk of the same and agree that KK shall not be held responsible for it or any resulting injuries, losses, damages, costs or expenses. I further certify that my dog has not harmed or demonstrated aggressive or threatening behavior toward any human being and/or another animal.

Dog Owner (**Client**) acknowledges that their dogs must attend day care a minimum of one day any week the daycare is open for business. **Client acknowledges that Kampers are picked up between 7 am. & 10 .m. and dropped off between 2 pm. & 6 pm. Specific times cannot be requested nor guaranteed. Walk-in service is available between 7 am & 10 am and dog(s) must be picked-up between 2 pm & 5pm.**

**Client makes the following representations and agreements about Dog(s)**

- \_\_\_ Dog is licensed and the license is current. **(Must provide copy of County license certificate)**
- \_\_\_ Dog has been vaccinated against rabies, and vaccinations are current. **(Must provide proof of vaccinations)**
- \_\_\_ Dog has been neutered or spayed. (Too young? \_\_\_\_\_) **(Must be spayed/neutered after 6 months of age)**
- \_\_\_ Dog is friendly toward children \_\_\_\_\_ and adults. \_\_\_\_\_

**Legal Provisions:** This Agreement is binding upon Client, the spouse of Client, and the children of Client. This Agreement supersedes all prior discussions, representations, warranties and agreements of the parties, and expresses the entire agreement between Client and KK regarding the matters described herein. The parties confirm that, except for that which is specifically written in this Agreement, no promises, representations or oral understandings have been made with regard to the Dog or anything else. Without limiting the generality of the foregoing, this Agreement may be amended only by a written instrument signed by both the Client and KK. Any remedy provided in this Agreement is in addition to any and all other remedies provided by law or equity. If any provision of this Agreement is invalid, void or unenforceable, they will be severed and the remaining provisions shall be given full force and effect.

**For good and valuable consideration, the parties agree as follows:**

1. KK agrees to provide the following services at our Facility located at: 389 Requeza St., Encinitas, CA 92024.
  - a. Doggie Daycare and related optional services including; Obedience training, behavior modification, field trips and baths.
  - b. KK may provide hikes and other off-site activities. **(Exception: If dog owner does NOT want dog(s) to participate in off-site activities. Dog owner must initial here: \_\_\_\_\_)**
2. **Compensation:** (see section 4, 4.1 &4.2 for refund policy) Client agrees to pay KK the current fee for all daycare and optional customer approved services provided. The current fee schedule can be found on our website at:

4. **Payment Policy:** Client understands and agrees that payment is due at the time service is rendered unless pre-paying for services or paying by credit card. Any Client paying by check must pay at the time services are rendered (at pick-up time) or they can pre-pay or purchase a prepaid discount package. Credit Card Clients will be billed every two weeks after services have been rendered and on a regular two week billing cycle. There is a .50 cent per day/per dog surcharge for using a credit card. **Exception:** Clients paying by credit card, and purchasing a prepaid discount package with recurring billing, will have the .50 cent surcharge is waived.
5. **Cancellations and Refunds:** \_\_\_\_\_ (client initials) At KK’s sole election, KK duties hereunder shall terminate if **(a)** in KK’s sole judgment Dog is dangerous or vicious to KK’s employees or agents or any other person or animal, or **(b)** Client breaches any term or condition of this Agreement. Upon termination in accordance with the foregoing, KK’s duties shall terminate but all other provisions of this Agreement shall continue in full force and effect. **(4.1)** Cancellation – Client agrees to contact KK, either by email or phone call no later than 8 p.m. the evening before dog is scheduled to be picked-up for daycare, notifying KK of cancellation of service for that day. If no notification of cancellation is received by that time, and before actual pick-up, and client is a “no-show” or cancels once we arrive, client agrees to be charged for that day’s service at the daily rate currently being charged. **(4.2)** If Client decides to terminate doggie daycare services, Client shall notify KK of intent to cancel within 45 days of last date of service. No refund will be issued if notification of cancellation is not received within this time frame. Client will be entitled to a refund of one-half of any prepaid fees left, less any outstanding unpaid fees for services on account, and a credit will be issued for remaining balance after refund. Credits are transferrable and can be gifted. (All dogs must be approved by KK prior to gifting any credits.)If payment has not yet been made for services already rendered, client agrees to immediately pay and settle current account balance up to the last date of service.

**Dog Owner’s (Client) Assumption of Risk:** Client understands that doggie daycare in an off-leash play environment and that during normal dog play, rough-housing is inherent and that their dog may sustain injuries including but not limited to scratches, punctures. All dogs are divided into appropriate play-groups and all play is carefully supervised. Any injury will be brought to the attention of the owner upon van drop-off or client pick-up. A KK manager will contact the owner by phone if the owner is not at home.

**Client initials:** \_\_\_\_\_ I certify that Dog is in good health and has not been ill with any communicable conditions within the past 30 days. I certify that my dog has not been exposed to Rabies, Distemper, Hepatitis, Para influenza, Parvovirus, and Bordetella (kennel cough) within a 30-day period prior to enrollment. KK requires that all dogs be spayed or neutered, licensed and be current on all vaccinations. I understand there is a monthly \$25.00 account maintenance fee if I fail to keep all required documents including proof of vaccinations and a copy of valid certification of dog license on-file with KK current and up-to-date. **Client initials:** \_\_\_\_\_ I acknowledge that all dogs are supervised, trained, groomed, or otherwise handled or cared for by KK personnel without liability on the part of KK or its representatives for loss or damage from disease, running away, theft, fire, injury to persons, other pets, or property by said pet, or other unavoidable causes, due diligence and care having been exercised.
