THIS AGREEMENT ("Agreement") is by and between "Kamp Kanine" and the Owner of the "Dog(s)" known as "Client"

**1. Client makes the following representations about Dog(s)**

**3. Dog Owners Assumption and Release of Liability:**

- 3.1.** I certify that I am the legal Owner of Dog(s), indicated above. I understand that in admitting my dog for services at their facility KAMP KANINE has relied upon my representation that my dog is in good health, has not been exposed to any communicable diseases within the last 30 days and has not injured or shown aggression or threatening behavior towards any person or dog.
- 3.2.** I understand that Kamp Kanine requires that all dogs attending daycare must be spayed or neutered by 6 months of age, licensed and current on all vaccinations and that I must provide a copy of a valid San Diego County license certificate and proof of vaccinations.
- 3.3.** I further understand that KAMP KANINE, their owners, staff, partners and volunteers, will not be liable, financially or otherwise for injuries to my dog, myself or any property of mine while my dog is participating in services provided by KAMP KANINE. I hereby release KAMP KANINE of any liability of any kind arising from my dog's participation in any and all services provided by KAMP KANINE.
- 3.4.** I further understand and agree that any problems with my dog, behavioral, medical or otherwise will be treated as deemed best by the staff of KAMP KANINE and in their sole discretion what they view is in the best interest of my dog. I assume full financial responsibility and all liability for any and all expenses involved with the behavior and health of my dog.
- 3.5.** I further understand that there are risks and benefits associated with an off-leash, cage free socialization environment for dogs. I agree that the benefits outweigh the risks and that I accept these risks. I desire a socialized environment for my dog while participating in the services provided by KAMP KANINE and while in their care. I understand that while the socialization and play is closely and carefully monitored by KAMP KANINE staff to prevent injury, it is still possible that during the course of normal play my dog may receive nicks, scrapes, scratches, punctures, cuts and other injuries from roughhousing with other dogs. Any discovered injuries to me by staff upon pick-up.
- 3.6.** I further understand that I am solely responsible, financially or otherwise, for any harm caused by my dog including bites or injuries to other dogs or any human including staff members, visitors or guests or any damage caused by my dog while my dog is attending daycare or while participating in any services provided by KAMP KANINE.
- 3.7.** I understand by allowing my dog to participate in services offered by KAMP KANINE that I am granting my permission for KAMP KANINE to take photographs or use images of my dog in print form or otherwise for publication and/or promotion.
- 3.8.** I understand that if my dog(s) is not picked up on time from kamp as specified in a separate agreement I will be charged for the continuing care of my dog(s) and Kamp Kanine will take whatever action is deemed necessary for the continuing care of my dog(s).

**4. Dog Owner’s Assumption of Risk:** Client acknowledges that Kamp Kanine’s Premises, Vehicles, Clients Home, Business and any Kamp Kanine’s off-site locations, and the animals, items and activities thereon, pose dangers to people and animals. Such dangers include, by way of example and not limitation, animals that can bite, nip, trip, knock down, and fight, indoor and outdoor surfaces that may be slippery, and activities involving client’s dog and/or other dogs that can result in injury or death from bites or other causes. Client hereby releases Kamp Kanine and its owners, principles, employees and agents from any and all liability, including injury or death arising from their dog’s attendance and participation in activities and canine socialization at Kamp Kanine. Furthermore, if clients dog becomes pregnant, gets fleas, bee stings, spider bites, snake bites, ticks or worms, escapes, contracts any illness or disease, on or off Kamp Kanine’s Premises, Vehicle, Clients Home, Business, or Kamp Kanine’s off-site location, client accepts the risk of the same and agrees that Kamp Kanine, it’s owners, principles, employees or agents shall not be held responsible for it or any resulting injuries, death, losses, damages, costs or expenses.

**5. For good and valuable consideration, the parties agree as follows:** Client agrees to pay Kamp Kanine the current fee for all daycare and optional customer approved services provided. The current fee schedule is available on our website. Client acknowledges Dog(s) that are on Daily Dog rate may be charged the Single dog rate if daily attendance requirement is not met. Client further understands that Kamp Kanine may charge a monthly \$25.00 account maintenance fee if after written notification from Kamp Kanine of expired required documents Client fails to provide Kamp Kanine with said documents within 30 days of the written notification to client. **Monthly Account Maintenance Fee is waived if all required documents have been received.**

**6. Payment Policy:** Client understands and agrees that payment is due at the time service is rendered or can purchase pre-paid packages. **Any check returned for any reason will incur a \$20.00 returned check fee which will be charged to the clients account or outstanding balance.** All customers are required to keep a valid credit card on file. The card will be used for services rendered if customer agrees to recurring payments or as a back-up billing option if customer pays by check and (a) check is returned unpaid for any reason and remains unpaid or (b) account balance remains unpaid for 10 days past the due date. The credit card will also be used in the event any emergency veterinary services must be paid at the time the dog is admitted for treatment. Customer agrees to fill-out a separate Credit Card Authorization as part of this agreement. Client agrees to notify Kamp Kanine of any billing discrepancies within 45 days from date discrepancy is discovered.

**7. Termination of Services, Cancellation and Refund**

**Client initials:**  **My initials indicate I have read 7. through 7.2 and agree to the following policies:** At Kamp Kanine’s sole election, Kamp Kanine shall terminate service if (a.) at Kamp Kanine’s sole judgment Dog is dangerous or vicious to Kamp Kanine’s employees or agents or any other person or animal, or (b.) Client breaches any term or condition of this Agreement. Upon termination in accordance with the foregoing, Kamp Kanine’s services and duties shall terminate but all other provisions of this Agreement shall continue in full force and effect.

**(7.1) Cancellation** – Client agrees to contact Kamp Kanine, either by email or phone call no later than 6:30 a.m. the day the dog is scheduled to be picked-up for daycare, notifying Kamp Kanine of cancellation of service for that day. **Clients cancelling a pre-scheduled service date after 6:30 am must directly call or text the van driver.** If no notification of cancellation is received by that time, and before actual pick-up, or clients cancels service once we arrive is considered a “no-show” and client agrees to be charged a “no-show” fee.

**(7.2) Refund** - If Client decides to terminate doggie daycare services, for any reason, Client shall notify Kamp Kanine of intent to cancel within 45 days of last date of service. No refund will be issued if notification of cancellation is not received within this time frame. With proper notification, Client will be entitled to a refund of one-half of any prepaid fees left on account and a credit will be issued for remaining balance after refund. Credits are transferrable and can be gifted. (All dogs must be approved by Kamp Kanine prior to gifting any credits.) If payment has not yet been received for services already rendered, Client agrees to immediately pay and settle current account balance up to the last date of service.

**8. Legal Provisions:** This Agreement is binding upon Client, the spouse of Client, and the children of Client. This Agreement supersedes all prior discussions, representations, warranties and agreements of the parties, and expresses the entire agreement between Client and Kamp Kanine regarding the matters described on pages 1 and 2 of this agreement. The parties confirm that, except for that which is specifically written in this Agreement, no promises, representations or oral understandings have been made with regard to the Dog or anything else. Without limiting the generality of the foregoing, this Agreement may be amended only by a written instrument signed by both the Client and Kamp Kanine.
