Supplemental Day Care Agreement

Customer Walk-in Agreement

This agreement supplements the previously signed Doggie Daycare Agreement. All policies and provisions of the attached or previously signed Doggie Daycare Agreement remain in full force and effect and are not amended by this agreement.

Customer acknowledges that their dog(s) must attend day care a minimum of one day any week the daycare is open for business.

By completing this form, the customer requests their dog(s) be registered with Kamp Kanine as an approved walk-in. The client's dog(s) will remain eligible to be placed on the regular Kamp Kanine van pick-up and drop-off schedule as space and time requirement for notification permits. The customer agrees to abide by the policy outlined below as a requirement for participating in the walk-in program.

Walk-in Policy

- Unless paid for in advance, services must be paid for at the time the dog(s) is dropped off.
- Client, or pre-approved authorized person, must sign dog(s) in and sign dog(s) out each service day. We must have client's written approval for each person allowed to pick-up dog(s).
- Dog(s) can only be dropped-off and checked-in between 7 a.m. and 11 a.m. and must be picked-up and checked-out between 2 p.m. and 6 p.m.
- Early check-in and early check-out is not permitted.
- For any dog not picked up by 6 p.m., client will be charged a \$1.00 late fee for each minute the dog remains in Kamp Kanine's care after 6 p.m. Any late fee must be paid at time of pick-up.
- Kamp Kanine's office time clock is the only clock that will be used to determine pick-up and drop-off times.
- We do not allow half-day or partial-day visits outside the stated service hours in this agreement.
- Should the dog(s) remain at the daycare facility past 6:30 p.m., the dog(s) will be sent home with a qualified daycare employee and the client will be charged an overnight lodging fee of \$100.00 per dog. The client must pick-up the dog(s) the following day during drop-off or pick-up hours only. The daily rate per day, per dog will be charged for any lodged dog(s) that are not picked up until the 2 p.m. to 6 p.m. timeframe.
- The daily per dog, per day rate will be charged if van service is used for either pick-up or drop-off unless owner lives within a 5 mile radius of the facility in which case an additional van service fee of \$5.00 will be charged for every drop-off or pick-up requested. Outside of 5 mile radius a van service fee of \$10.00 will be charged.
- When van service is needed, the request must be made prior to or on the day of service, and then only before 6 a.m. for pick-up, and 1 p.m. for drop-off.
